

S. R. O. No. 1056/2010.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968) read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Special Rules for the Kerala Technical Education Service issued under notification G.O.(Ms.) No. 284/Public (Rules) Department dated 2nd September, 1967 and published in part I of the Kerala Gazette No. 37 dated 19th September, 1967, namely:—

RULES

1. *Short title and commencement.*— (1) These rules may be called the Kerala Technical Education Service (Amendment) Special Rules, 2010.
- (2) They shall come into force at once.

2. Amendment of the Rules.—In the Special Rules for the Kerala Technical Education Service,—

(1) in rule 1,—

(i) under the heading "CLASS A - ADMINISTRATION" —

(a) for category "1B. Joint Director (Polytechnic Stream)", the following category shall be substituted, namely:—
"1B. Senior Joint Director of Technical Education (Polytechnic Stream)/Joint Director of Technical Education (Polytechnic Stream)/Joint Controller of Technical Examinations (Polytechnic Stream)";

(b) for category "2. Deputy Director of Technical Education (General)", the following category shall be substituted, namely:—
"2. Deputy Director of Technical Education (Polytechnic Stream)/Deputy Controller of Technical Examination (Polytechnic Stream)";

(c) for category "4. Assistant Director of Technical Education (Curriculum Development)", the following category shall be substituted, namely:—

"4. Assistant Director of Technical Education/Assistant Controller of Technical Examination";

(d) after category 4, the following category shall be inserted, namely:—

"5. Technical Officer/Project Officer";

(ii) under the heading "CLASS B - ENGINEERING COLLEGES",—

(a) after category 11, the following category shall be inserted, namely:—

"11A. System Analyst";

(b) for category "12. Computer Operator", the following category shall be substituted, namely:—

"12. Computer Programmer";

(iii) for the heading "CLASS C - POLYTECHNICS INCLUDING RESIDENTIAL WOMEN'S POLYTECHNIC COLLEGE, PAVYANNUR AND GOVERNMENT POLYTECHNIC COLLEGE, NEYYATTINKARA.", the following heading shall be substituted, namely:—

"CLASS C - POLYTECHNICS";

(iv) under the heading "CLASS C - POLYTECHNICS" as so substituted,

(a) after category 1B the following category shall be inserted, namely:—
"1C. Head of Section in Commercial Practice";

(b) the category "2A. Post Diploma Lecturer in Engineering/Technology", shall be omitted;

(c) after category "2B. Lecturer in Computer Application and Business Management", the following categories shall be inserted, namely:—

"2C. Lecturer in Commerce;

2D. Lecturer in Commercial Practice;

2E. Lecturer in Textile Technology;

2F. Lecturer in Printing Technology";

(d) the category "4. Analyst" shall be omitted;

(v) for the heading "CLASS D - JUNIOR TECHNICAL SCHOOLS" the following heading shall be substituted, namely:—
"CLASS D - TECHNICAL HIGH SCHOOLS";

(vi) under the heading "CLASS D - TECHNICAL HIGH SCHOOLS" as so substituted, for the entry "SUPERINTENDENT" the following shall be substituted, namely:—
"SUPERINTENDENT, TECHNICAL HIGH SCHOOLS";

(vii) the heading "CLASS E - INSTITUTE OF TEXTILE TECHNOLOGY, TRIVANDRUM AND TEXTILE WING OF POLYTECHNIC, CANNANORE" and all the entries thereunder shall be omitted;

(viii) the heading "CLASS F - WOMEN'S POLYTECHNICS" and all the entries thereunder shall be omitted;

(ix) the heading "CLASS J - INSTITUTE OF PRINTING TECHNOLOGY" and all the entries thereunder shall be omitted;

(x) after the existing entries, the following heading shall be inserted, namely:—
"CLASS K - GOVERNMENT COMMERCIAL INSTITUTES";

(xi) under CLASS K as so inserted, the following category shall be inserted, namely:—

"SUPERINTENDENT, GOVERNMENT COMMERCIAL INSTITUTES";

(2) in sub-rule (a) of rule 2,—

(i) under the heading "CLASS A - ADMINISTRATION",—
(a) for category "1B. Joint Director (Polytechnic Stream)" in column (1) and entries against it in column (2), the following categories and entries shall respectively be substituted, namely:—

3. In the absence of suitable candidates under item (1) and (2) above, by transfer from the category of Demonstrator/ Draftsman Grade-II/ Workshop Instructor/Instructor Grade-II.

4. In the absence of qualified candidates under item (1), (2) and (3) above, by direct recruitment”;

(v) the heading “CLASS E - INSTITUTE OF TEXTILE TECHNOLOGY AND TEXTILE WING OF POLYTECHNIC, CANNANORE” and the entries thereunder in column (1) and (2) shall be omitted;

(vi) the heading “CLASS F - WOMEN'S POLYTECHNICS” and the entries thereunder in column (1) and (2) shall be omitted;

(vii) the heading “CLASS J - INSTITUTE OF PRINTING TECHNOLOGY” and the entries thereunder in column (1) and (2) shall be omitted;

(viii) under the heading “CLASS H - INDUSTRIAL EDUCATION” for category “Inspector of Industrial Schools” in column (1) and the entries against it in column (2), the following category and entries shall respectively be substituted, namely:—

Explanatory Note

(This does not form part of the notification but is intended to achieve the general purport.)

In the Special Rules for the Kerala Technical Education, Service issued as G. O. (Ms.) No. 284/Public(Rules) Department dated 2nd September, 1967 and published in part I of the Kerala Gazette No. 37 dated 19th September, 1967, Polytechnics come under CLASS-C and Women's Polytechnics come under CLASS-F. The qualification prescribed for various posts such as Principals, Lecturers etc. are entirely different for those two classes of institutions. This has created problem when question of promotion to higher posts are considered. Similarly, Institute of Textile Technology, Trivandrum and Textile Wing of Polytechnic, Kannur and Institute of Printing Technology are also classified separately as CLASS-E and CLASS-J. These institutions have lost their unique status as they offer Diploma Course in other disciplines also. Vide G. O. (P) No. 126/2009/H.Edn. dated 5-8-2009 the Class-C Polytechnics have been changed to CLASS-C—POLYTECHNICS INCLUDING RESIDENTIAL WOMEN'S POLYTECHNIC COLLEGE, PAVYANNUR AND GOVERNMENT POLYTECHNIC COLLEGE, NEYYATTINKARA. In order to give a unified structure for the Polytechnics in the Special Rules, it is necessary to bring all the Polytechnics imparting Diploma Course lying now under CLASS-E, CLASS-F and CLASS-J

into the common group viz., CLASS-C. Further some posts both in Engineering ~~stream~~ stream and Polytechnic stream were newly created which are not included in the Special Rules of Kerala Technical Education State Service and some modifications in the method of appointment and qualifications are necessary from the existing standard.

As per the G. O. (Ms.) No. 54/2008/H.Edn. dated 24-5-2008 the post of Computer Operator has been re-designated as Computer Programmer without changing age, qualification and method of appointment etc. It is necessary to give statutory validity by bringing the amendment in Special Rules for Kerala Technical Education Service. The Qualification prescribed for Computer Operator i.e. the certificate issued by Computer Society of India or equivalent is confusing and has created problem on recruitment. An appreciable change has also occurred in the field of Information Technology and allied disciplines and qualifications also need changes. Hence the modifications are necessary.

Posts of System Analyst are created newly in the Engineering Colleges and Office of the Controller of Technical Examination. These are not included in the Special Rules for Kerala Technical Education State Service.

The post Diploma Course in Engineering/Technology is not in existence now. Hence the category has to be omitted from the rules.

Junior Technical Schools are renamed as Technical High Schools. The feeder category and qualification needs to be revised. In order to incorporate the above, Government have decided to amend the Special Rules.

This Notification is intended to achieve the above object.
